
What you may not know about your lake!!

Every year multiple surveys are performed on our lake and annual reports for all surveyed lakes are compiled. The most recent report has just become available on line at the VLMP website. This document contains a wealth of information on the status of our lake. Other years are also available.



Local surveyors include our own Board members. Lew Wetzel measures key water quality indicators; Phosphorous levels, water clarity and dissolved oxygen. He also takes lake water temperature readings multiple times and in multiple locations.

Pixie Williams and Fred Cummings have performed the important Invasive Aquatic Plant Survey for many years. Last year they were joined by two new plant patrollers, the Barbers. Training and certification are required to lead these surveys but free training is available at many sites during the summer through VLMP. This summers dates are as follows:





Ice Out and Ice In dates are statistics that have been collected systematically over the years for lakes in the state of Maine. Recent Ice Out dates for Pleasant Lake were April 22 this year and almost a month earlier last year on March 23. Similarly for Parker Pond, April 19 2011 and March 21, 2010. All the snow helped to insulate the ice!

• OFF THE LIST -- a Joel Bloom success story

Last fall Maine's Dept. of Environmental Protection announced that Pleasant Lake, which had been listed as one of 34 water bodies in the state with an infestation of Variable Leaf Milfoil, has been officially removed from the list and declared free of this invasive aquatic plant. As many of you know this plant was first noticed 10 years ago and it is through the efforts of many current board members that this infestation has been eradicated. The systematic use of custom designed "benthic barriers" was the key to our success and Joel would be proud. We are making progress in our Lily Brook efforts and hope for the same success.

BOAT INSPECTIONS TO CONTINUE

We will continue the important vigilance of checking all exiting and entering watercraft from Pleasant Lake and Parker Pond. Our boat ramp inspections during weekends and holidays will be staffed at all three ramp locations for this summer. Fred Cummings will again be coordinating this critical work. Please remember to register your boats as these funds contribute to the State's effort to eliminate invasive plants in our lakes.
