Steve has been managing the Maine Department of Inland Fisheries and Wildlife Regional Fish Hatchery for many years and has agreed to inform us on all the important work that he and his staff do. Many of you may have stopped by to feed the trout or see the "albino salmon" over the years, but you will be totally surprised at all the sophisticated tasks and research that goes on in Casco and in Raymond. Pleasant Lake is the water source for the hatchery and its health is critical to help provide excellent fishing stock for many of the region's lakes. An avid fisherman himself, Steve is happy to tell us all about the fish that inhabit our lakes and how they have changed or fared over the years. The Q & A session should be fun, so bring your questions!

ICE IN - Parker Pond froze over December 24th, and Pleasant Lake on January 1. ICE OUT- Parker Pond-April 18 and Pleasant Lake-April 23. In both lakes, these dates are within 1-2 days of last year's, despite the cold harsh winter.


Courtesy Boat Inspections

The DEP reports that now over one million dollars is contributed towards early detection or the prevention of the spread of invasive plants by the annual sale of Maine Boat Registration stickers.

Please be sure you purchase this year's and help "Stop Aquatic Hitchhikers- Preserve Maine Waters".

In 2014, 116 lakes had "CBI" programs in operation and over 80,000 boats were inspected with upwards of 100 invasive plants found on boats entering or exiting lakes.

We continue to monitor 3 locations on our lakes every weekend of the summer in an effort to detect invasive aquatic plants. We will augment our educational leaflet distribution to arriving boaters (and, we are hopeful, with volunteer help, to those with docks on the lake) so that all





LakeSmart is Back!

"LakeSmart lets you have your lake..... and keep it too!"

An excellent and comprehensive evaluation and certification program for waterfront property owners began nearly 10 years ago, but until recently it had not been adequately funded to make an impact. That now seems to have changed, and with renewed funding and non-profit administration of this effort, significant expansion of this program is getting traction. Properties that meet the standards of a four part evaluation are awarded a certification, and those requiring modifications are provided with detailed (often low cost) ways to lessen negative impacts on their lakes. Focus is on preventing excess stormwater runoff- the single most detrimental result of lakefront development. Research has shown that LakeSmart certified properties are similar to undeveloped land and protect benefits like clean, clear water, abundant wildlife, and recreational opportunities.
