COURTESY BOAT INSPECTION PROGRAM

Our 2021 program to inspect boats, trailers, and other personal watercraft for invasive plants ran from Memorial Day through the end of September. Inspectors staffed the Casco ramps serving Pleasant Lake and Parker Pond on weekends and holidays. We reported this inspection information to the State of Maine:

We performed fewer inspections in 2021 than in 2020, which may be related to July's cold and wet weather. We're pleased that our inspectors found no invasive species. The program would not exist without the invaluable guidance of and administration by Lakes Environmental Association (LEA) in Bridgton.

PURPLE LOOSESTRIFE

Our CBI inspectors found no invasive plant fragments, but we cannot be complacent. In late summer, Association member Rona Fried spotted purple loosestrife growing along the shoreline on the east side of Pleasant Lake in the Casco cove. Members attempted to remove this growth but were hampered by difficulty identifying the plants after their flowers were gone and by high winds that hampered lake access to them. This group of plants was near another growth that Rona identified in 2020, which members Holly and Art LeBlanc subsequently removed.



The presence of more purple loosestrife in the area is a concern. As described on a State of Maine website it is "an attractive but invasive perennial (that) has become established in a wide range of habitats including riverbanks, lake, and pond shores."

Maine Audubon describes it as a terribly invasive plant that can be found across the country. With tall, pinkish purple racemes it is an unfortunately beautiful plant, but it can quickly take

over swamps and meadows. Without some control, this non-native flower will continue to push out our native flora and create monocultures unsuitable as habitat for other wildlife.

It has an affinity for water --- it's frequently seen in roadside ditches or highway median strips -- but is not always visible to those patrolling for invasive aquatic species in canoes and kayaks. If it is growing on a lakeside bank, then it is on someone's property. Eradicating it requires the landowner's approval.

Next spring, we will remove the existing plants, inspect the area for other growth, and provide more information to members about how to identify and remediate this invader. Until then we need to educate ourselves to ensure it does not expand its foothold on our lakes.
