Dear Members of the Pleasant Lake/Parker Pond Association (PL/PPA) and others who enjoy our lakes:

"Priceless Prevention versus Expensive Control" is the title of an article in <u>Lakes Environmental Association's</u> (LEA) Lake News Spring/Summer 2022. The article's message is familiar to anyone who follows the health of Maine's lakes. Infestations of invasive plants or critters, alum treatments to remediate algae blooms, and incidents of non-point source pollution are costly to fix and demand multi-year commitment of resources to monitor progress and prevent recurrence. Warming temperatures, shorter periods of ice-in, and more frequent and severe storms exert additional pressure on watershed integrity. Vigilant stewardship today minimizes expensive cleanup to tomorrow.

PL/PPA manages its finances to address both short-term and long-term needs. Our recurring annual expenses include the Courtesy Boat Inspection program, education and outreach, and PL/PPA governance and organization. Every year, after paying our bills, we reserve a certain amount of that year's revenue (member contributions, town contributions, and state grants) to apply to the following year's expenses. Any excess is reserved in "Joel's Fund", named after our founder and long-time President Joel Bloom. (Thanks to member Art LeBlanc for explaining this history at our 2022 Annual Meeting.) Joel's Fund is not large enough to solve every problem, but its existence will help us to respond to a serious threat if it arises. **An ounce of prevention is worth a pound of cure.**

2022 COURTESY BOAT INSPECTION (CBI) REPORT

Our 2022 Courtesy Boat Inspection (CBI) program ran from May through September at the Casco ramps in Pleasant Lake and Parker Pond. Our inspectors found no invasive plants.

Here are the details:

2022 CBI Program	# of Inspections	# of Inspections Where Fragments Found	# of Confirmed Invasive Plants	Total Paid Inspector Hours
Pleasant Lake - Casco Ramp	408	15	0	320
Parker Pond	148	0	0	212
TOTALS	556	15	0	532

The program cost \$9,576. A Maine CBI grant provided \$2,200. Our Association paid the \$7,376 balance.

We are committed to reinstating courtesy boat inspections in 2023 at the Pleasant Lake Otisfield boat ramp. We will work out hiring, training, supervision, and payroll details with the town over the coming months.

UPDATES

WATERSHED PROTECTION PAMPHLET

With the permission of the Town of Otisfield, we are revising and updating the Watershed Protection Pamphlet that was originally published by the Otisfield Conservation Committee in 2009. Our goal is that both Otisfield and Casco will endorse the pamphlet and distribute it in their respective town offices. The pamphlet focuses on steps home and property owners, long-term and seasonal renters, and lake users can take to protect our watershed. We expect to complete the pamphlet before next summer.

LOON RESTORATION PROJECT

As discussed in recent newsletters, we explored introducing loon nesting rafts as part of the Maine Loon Restoration Project. Unfortunately, the locations we scouted were too vulnerable to waves and human interference to take further steps. Also, the Project's daunting monitoring and reporting requirements may have discouraged prospective community volunteers. We will continue loon monitoring and re-explore participation in the program if circumstances change.

REMEMBERING BOB TOLL

The PL/PPA community mourns the loss of Bob Toll, who passed in early October at the age of 81. Bob's long connection to Pleasant Lake began as a camper at Camp Powhatan and lives on in his wife Jane and their children and grandchildren.
